

Data on legal aid for children & young people

Compiled by JustRights, 19/10/11

1. Summary of Key Data

- Current annual civil legal aid spending on children and young people (out of a total budget of £860m):
 - o £145m on 41,000 cases involving under 18s (of which £120m is on family cases)
 - o £125m on 124,000 cases involving 18-24 year olds (of which £90m is on family cases)
 - Over 80% of current spend is on legal representation (of which 60% is accounted for by under 18s), with remainder on legal help (of which three-quarters is accounted for by 18-24s)
- 6,000 children under 18 and 69,000 young people aged 18-24 will lose entitlement to civil legal aid if the proposals contained in the Legal Aid, Sentencing and Punishment of Offenders Bill become law including:
 - o 25,840 social welfare law cases, costing £5.8m per year, including:
 - 9,040 debt cases costing £2.1m
 - 1,990 employment cases costing £0.5m
 - 5,680 housing cases costing £1.4m
 - 9,130 welfare benefits cases costing £1.8m.
 - o 10,990 immigration and asylum cases costing £21.7m
 - o 34,580 family cases (all for 18-24s) costing £25m
 - o 1,090 clinical negligence cases costing £5.5m
 - o 210 education cases costing £0.6m
 - o 2,025 other cases costing £2.9m
- The total cost of all the cases being taken out of scope is £10m for children under 18 and £40m for young people aged 18-24
- Community Legal Advice telephone service helped 21,149 children and young people in 2010/11
 - o Total cost of CLA for C&YP was £2m in 2010/11, up from £1.1m in 2008/09 an 89% increase
 - Average cost of a CLA case for people of all ages has increased by 19.9% in two years
 - o 18-24 young adults' cases cost on av. £20.38 (17%) less than those of adults aged 25 & over; whilst children's cases cost £28.50 (24%) less





7. <u>Legal aid – children at risk of abuse; international child abduction</u>

Parliamentary answer by Jonathan Djanogly MP (Parliamentary Under Secretary of State (HM Courts Service and Legal Aid), Justice; Huntingdon, Conservative) in response to question by Andy Slaughter MP

Hansard (Citation: HC Deb, 18 July 2011, c736W)

To ask the Secretary of State for Justice how many cases where legal aid advice or representation was provided, involved (a) children at risk of abuse and (b) international child abduction in 2009-10; and what the cost to the public purse was of the legal aid provided in such cases.

Table 1 shows the number of public law family cases and spend for 2009-10. It is considered that it is likely that children funded in these categories may be at risk of abuse.

Table 2 shows the number of international child abduction cases and expenditure funded under a legal aid certificate. However, there may also be other types of matters, such as wardship which involve issues of child abduction. These figures exclude advice and assistance under Legal Help as the LSC do not record this level of detail under legal help.
